Introduction

There's no contact form to collect your data, so in terms of threats to your digital and personal security, this site is about as mild as it gets.

However, I might use google analytics one day to see if I have any site traffic, and then who knows, I might start wearing suits, then feel like I want to start taking over stuff. So with that in mind, here is my privacy policy for when I may at least begin collecting your data.

David Nutley ("I" "us", "we", or "our") operates the www.davidnutley.com website (the "Service"). This page informs you of my policies regarding the collection, use, and disclosure of Personal Data when you use this Service and the choices and rights you have associated with that data. I am a data controller in respect of your Personal Data. This means that I make decisions about how to use your Personal Data for my business, and I am legally responsible for those decisions. I'll only use your Personal Data in accordance with the General Data Protection Regulation (GDPR) and other applicable laws. I'll obtain your consent to my use of your Personal Data where it's necessary or appropriate.

I use your data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this policy.

What data I collect

I collect several different types of information for various purposes to provide and improve our Service to you. Types of data Collected:

Personal Data

While using our Service, I may ask you to provide me with certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally identifiable information may include, but is not limited to:

- Email address;
- First name and last name;
- Phone number;
- Cookies and usage data.
- You directly (e.g. from information which you provide to us in forms, documents and correspondence).
- You indirectly (e.g. information collected when you browse our website, such as your IP address).
- From third parties including search engines.
- Publicly available registers (e.g. the electoral roll and Companies House).
- Social media (e.g. LinkedIn, Facebook and Twitter).

Usage Data

I may also collect information about how the Service is accessed and used ("Usage Data"). This Usage Data may include information such as your computer's Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our Service that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

What I do with the data I collect

David Nutley uses the collected data for various purposes:

- To provide and maintain the Service;
- Respond to an enquiry you make about our services;
- To notify you about changes to our Service;
- To allow you to participate in interactive features of our Service when you choose to do so;
- To provide customer care and support;
- To provide analysis or valuable information so that we can improve the Service;
- To monitor the usage of the Service;
- To detect, prevent and address technical issues;
- Comply with our legal obligations;
- Further our legitimate business interests (see legitimate interests section).

Our Legitimate Interests

We may collect and use Personal Data for our legitimate interests, such as:

- Selling and supplying our products and services;
- Handling contacts, queries and disputes;
- Promoting, marketing and advertising our products and services;
- Understanding customer activities, preferences and needs;
- Improving our products and services;
- Complying with our legal obligations and handling legal claims.

Your Consent To My Use Of Your Personal Data

- There are six legal bases on which I may be entitled to collect and use your Personal Data, which means that your express consent is not always required.
- For example, the law allows me to collect and use Personal Data to perform contracts, where this is necessary for our legitimate interests – provided my use of the Personal Data is fair and balanced.
- I'll obtain your consent to my use of your Personal Data where this is necessary or appropriate, including where this is required for direct marketing purposes.
- Where you provide me with your consent, you can withdraw this at any time by contacting me at david@nutleys.com. Alternatively, you can write to me using the address details provided at the end of this policy document.

Accuracy And Retention Of Personal Data

I verify Personal Data periodically to ensure that it's kept up-to-date.

I'll only retain Personal Data for as long as it's necessary for me to retain it. Generally, I'll retain Personal Data for the statutory retention and/or limitation period which is relevant to the Personal Data. When it's no longer necessary for me to retain your Personal Data, I'll securely delete it.

Transfer Of Data

Your information, including Personal Data, may be transferred to and maintained on computers located outside of your state, province, country or other governmental jurisdiction, where the data protection laws may differ than those from your jurisdiction.

If you are located outside the United Kingdom and choose to provide information to me, please note that I transfer the data, including Personal Data, to the United Kingdom and process it there.

Your consent to this Privacy Policy followed by your submission of such information represents your agreement to that transfer.

David Nutley will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organisation or a country unless there are adequate controls in place including the security of your data and other personal information.

Disclosure Of Data

Legal Requirements: David Nutley may disclose your Personal Data in the good faith belief that such action is necessary to:

- Comply with a legal obligation;
- Protect and defend my rights or property;
- Prevent or investigate possible wrongdoing in connection with the Service;
- Protect the personal safety of users of the Service or the public;
- Protect against legal liability.

Where it's necessary for me to share your Personal Data with anybody else, I'll comply with all laws, including the GDPR.

Service Providers

I may employ third party companies and individuals to facilitate my Service ("Service Providers"), to provide the Service on my behalf, to perform Service-related services or to assist me in analysing how my Service is used.

These third parties have access to your Personal Data only to perform these tasks on my behalf and are obligated not to disclose or use it for any other purpose.

Analytics

I will use Google Analytics to analyse the use of my website. Google Analytics gathers information about website use by means of cookies. The information is used to create reports about the use of our website. Information about your use of my website (including your IP address) may be sent to Google and stored on servers outside of the EEA. Google would then use this information to help me to analyse and improve my website, including providing me with reports. Google may also be required to transfer the information to third parties where required to do so by law, or where third parties provide services on Google's behalf.

- Your right to object to our use of your Personal Data;
- Your right not to be subject to a decision made by us based on automated processing of Personal Data;
- Your right to the prompt correction and/or completion of any inaccurate and/or incomplete Personal Data that I hold about you;
- Your right to be informed if your Personal Data has been compromised;
- Your right to request us to transfer your Personal Data to a third party;
- In certain circumstances, you may have the right to be forgotten (i.e. to require us to delete your Personal Data);
- In certain situations, you may have the right to restrict how I use your Personal Data (e.g. where there is a disagreement about its accuracy or legitimate use);
- Your right to complain about us to a supervisory authority (in the UK, the Information Commissioner's Office).
